In the Consideration of the mutual covenant and agreements set forth, and other good and valuable consideration. Lessor does hereby lease to Lessee, and Lessee does hereby lease from Lessor, The Firemen’s Pavilion situated at 2 S River St in the Borough of Athens, Bradford County, Pennsylvania, and here in after referred to as the “Leased Premises”.

**ARTICLE I: RENT**

Lessee agrees to pay to Lessor without any prior demand therefore, and as fixed minimum rent, the following schedule:

A 14 day notice of cancellation is required from lessee for a cancellation. All cancellations of less than 14 days’ notice will result in forfeiture of rental amount by lessee.

**ARTICLE II: CONDUCT OF BUSINESS**

Lessee shall not operate the leased premises for the use and purpose of a fund raising activity. Lessee shall be required to obtain necessary health certificates and beer licenses and present proof of them to Athens Borough Fireboard, two weeks prior to event. Consumption of alcoholic beverages needs approval by Athens Borough Fireboard and Mayor. All alcoholic beverages will be dispensed by the Lessee. The Lessee will be responsible for all aspects of and for this agreement. Athens Borough Fire Board representative may remain on premises to assure that the articles of this agreement are adhered to.

**ARTICLE III: MAINTENANCE AND WASTE AND NUISANCE**

Lessee shall maintain the building and other improvements constituting the leased premises and keep them free from waste or nuisance, and shall deliver up the premise in a clean and sanitary condition by 10:00 PM the day of rental event.

**ARTICLE IV: INDEMNITY**

Lessee agrees to indemnity and hold Lessor harmless against any and all claims, demands, damages, costs, and expenses, including reasonable attorney fees for the defense therefore, arising from conduct or management of Lessee’s business in the leased premises or from any breach on the part of the lessee, of any condition or employees, subtenants, concessionaires, or licensee’s in or about the leased premises. In the case of any action or proceeding brought against Lessor by reason of any such claim, Lessee on notice from Lessor, covenants to defend such action or proceeding by Counsel acceptable to Lessor.

**ARTICLE V: AUTHORIZATION**
